

The scope of the meeting was to deliver a presentation of the project and the expected results to interested parties and to establish the structure of the stakeholders working group. The PowerPoint presentation of the project as delivered by Mr. David Tsiskaridze is attached to the report. A second objective of the meeting was to

gather input from the participants and to feed it, if the case, into the implementation plan.

The presentation provided background information on the Technical assistance granted by UNEP through CTCN (Climate Technology Centre and Network) to Agency for Protected Areas and introduced IBDEC as the service provider in charge with implementing the measures sustained by TA.

The objective of the contract was presented, i.e. to benchmark, select, design, and test a suitable integrated monitoring and early warning forest fire detection system in Borjomi - Kharagauli National Park. It was stated that besides identification, design and build of the most suitable fire detection system in the protected area as a pilot project, training to users and administrators of the system will be provided and a monitoring policy will be developed and implemented. The aim of such a policy is to allow local populations with high risks of exposure to forest fire hazards to

take appropriate actions to avoid or reduce risks and to prepare effective responses, which is the ultimate scope of the project.

Further on, the presentation introduced the main activities and their expected results.

The main aspects that were highlighted regarded the following:

- the whole project is based on consultation processes with stakeholders and insertion of received feedback in the deliverables
- gender balance and an adequate representation from vulnerable groups are important for all project activities
- the scope is not only to identify the best solution for early fire detection and warning but also to identify financial resources for duplication of the pilot project in the whole protected area.

Thus, it was stressed the fact that the project will not provide a solution to cover the whole area of the natural park of Borjomi – Kharagauli, but a pilot system to be tested and further expanded once financial resources will be identified.

Afterwards it was opened discussion between the project team and stakeholders about project details.

Most questions were related to practical aspects such as the components of the system. It was explained that the actual architecture of both the physical system and the ITC component are to be established within the project following a survey of existing solutions and the results of the feasibility study.


