"Her demise is heartbreak-  
ing for me, as it is for millions  
the world over. In her vast

Recalling Mangeshkar as  
the "nightingale of Indian cin-  
ema and a legendary singer",  
vice-president M Venkaiah  
Naidu said India has lost its  
voice in the death of the singer,  
who enthralled music lovers in  
the country and across the  
globe with her sublime voice  
for many decades. "She was  
truly a musical ratna and had  
ruled the Hindi cinema like a  
queen for decades. Her demise  
has left a void that can't be fil-  
led. Lata ji will continue to live  
in the hearts of millions of ad-  
mirers through her timeless  
melodies," he said.

Ex-PM Manmohan Singh on  
Sunday also condoled Lata's de-  
mise and said India has lost a  
great daughter. "She was the  
"Nightingale of India" and  
through her songs made an im-

ness of Indian music. Her  
death is a personal loss for me."

Defence minister Rajnath  
Singh paid tributes to Man-  
geshkar at a poll rally in UP  
and said, "When anyone lis-  
tened to her song, 'Ae mere wa-  
tan ke logon, zara aankh mein

urally come to their eyes. I pay
